### **President's Report**

If you need repair or have an issue, please go to the Laundry room and fill out a work order. Dean picks up orders every day, he will do his best to get them completed in 14 days or less unless it's a major job.

I have had complaints of walkers without flashlights, don't be a statistic, USE A LIGHT!

You CAN NOT have people occupy your home if you are not in residence, if a visitor stays for over 30 days when you are in residence, they must be vetted.

If you have a problem with your Electric, Cable or Phone it is your responsibility to call FPL, Comcast, or your Phone provider.

If you have an issue with sewer, water, roofs or landscaping, and fallen trees, contact Jim Swindell. Fred Rood will be in charge of buildings including inside water and sewer. Grace will collect keys that are still needed for your Unit, and will be of assistance to Jim and Fred whenever needed.

I will be in charge of the Lake, retention pond, Clubhouse and Pool and will be in contact with Fred, Jim and Grace daily.

If you are traveling, have a safe trip and all of you have a great Summer.


#### From the Editor

I hope to continue to refine the process and welcome feedback and suggestions for the Web Site.



#### **Iridescent Mid-altitude Clouds**

On March 30, the people enjoying the pool at Tippecanoe observed what appeared to be a rainbow in the wispy clouds overhead. No one had ever seen anything like it. The colors were even more vivid looking through polarized sunglasses.

Here is a photo of a similar one, unfortunately the collected cell phone cameras weren't able to do it justice. It was most amusing watching six or seven Tippy friends squinting at their cellphones while trying to capture this beautiful phenomenon!

Cloud iridescence occurrence of colors in a cloud similar to those seen in oil films on puddles, located in the general vicinity of the sun or moon. It is a fairly common phenomenon. most often observed in altocumulus. cirrocumulus and cirrus clouds. The colors are usually pastel, but can be very vivid. When



occurring near the sun, the effect can be difficult to spot as it is drowned in the sun's glare. This may be overcome by blocking the sun with one's hand or hiding it behind a tree or building.



If parts of clouds contain small water droplets or ice crystals of similar size, their cumulative effect is seen as colors. The cloud must be optically thin, so that most rays encounter only a single droplet. Iridescence is therefore mostly seen at cloud edges or in semi-transparent clouds, while newly forming clouds produce the brightest and most colorful iridescence.
