

I was born in 1952 in Toronto attended school there and graduated from the University of Toronto. Shelley and I married before we graduated and then moved to Ottawa, in order for me to take a job with the Government of Canada, Shelley soon found work at Fisher Scientific. For the next thirty odd years I worked for various Departments and Agencies culminating at the Office of the Superintendent of Financial Institutions (OSFI). OSFI is charged with regulating the soundness of Banks, Insurance companies and other financial institutions in Canada. During my time there I became a union Steward with the Professional Institute of the Public Service of Canada (PIPSC), which represents over 60,000 members across Canada. Angus then said, "It's not brain surgery" and a guy in the second row put up his hand and said "I'm a neuro-surgeon ----". Angus interrupted

him and called for a coffee break. Sometimes it's hard working with professionals! This helped prepare me for lots of volunteer work during my retirement.

Shelley and I have two daughters, Hana and Julia and three granddaughters, Morgan, age 13, and twins Samantha and Emma, age 4. All of us live in Ottawa, Canada (at least during the summer).

We purchased our Condo in 2011 at Lake Tippecanoe, and I was elected to the Board of Directors five years ago, I'm proud to say that in spite of being a snowbird, and thanks to conference calls, I have not yet missed a meeting.
